Jan	8	The Executive Director meets with representatives of Deutsche Bank AG, Sylvie Matherat and Francesca Carlesi, to discuss the 2016 EBA stress test.
	13	Adam Farkas meets with Alison Cottrell, CEO of the Banking Standards Board, for an introductory meeting.
	14	The Executive Director joins a panel discussion at the Launch Banking Business Models Monitor 2015 for Europe event in the European Parliament, and speaks on Business models in European banking and implications for legislation and supervision.
	25	Adam Farkas meets with Tim Skeet (former Royal Bank of Scotland) of the International Capital Market Association (ICMA) to discuss current regulatory topics.  Moreover, Andrea Enria and Adam Farkas meet with Martin Anderson of Oliver Wyman to exchange of views on recent developments in the regulatory field.  That evening, the Executive Director delivers a keynote speech "Banking Regulation: preparing for tomorrow" at the European Risk Management Council.

During the meeting Pillar 2 and Maximum Distribution Amount (MDA), articulation of Minimum requirement for own funds and eligible liabilities (MREL) / TLAC, remuneration, technical standards on Revised Directive on Payment Services (PSD2), Net Stable Funding Ratio (NSFR), treatment of sovereign risk, review of internal models, interest rate risk in the banking book, future recommendations on retail financial services, and SME Supporting Factor are discussed.
