# Joint ESAs Consumer Protection Day 2024, 3 October 2024 – Registration

The European Banking Authority (EBA) processes your personal data to organise and manage the Joint ESAs Consumer Protection Day 2024 (further referred as "JECPD 2024"). The EBA processes your personal data based on Regulation (EU) 2018/1725 (EUDPR).

The following information is provided in accordance with Articles 15 and 16 of the EUDPR.

# What personal data do we process, for what purpose, who can access it and how long do we keep them?

The list consists of contacts that registered to attend the JECPD 2024 in person.

Personal data will be processed for the following purposes:

- To ensure registration for the event and attendance during the event
- To communicate further relevant information related to the JECPD 2024
- To prepare aggregated statistical reports



- To perform any JECPD 2024 follow-up actions (such as distribution of reports)
- To inform of shared content from the JECPD 2024 and the social events organised by the EBA (i.e. audio-video recording and photos) via communication channels (social media and website)

The EBA will process the following personal data:

- First name and last name
- E-mail address
- Job title
- Affiliation
- Date of birth
- Country
- Social media handler (only for speakers and organisations)

## On the day of the event, identification (ID card/passport/driving licence) will be required in order to access the venue.

Your personal data can be accessed by the relevant members of the organisation team of the EBA. Certain personal data will be shared with Central Bank of Hungary as co-host of the event.

We do not keep your personal information for longer than necessary for the purposes for which we collected it. However, we may keep your information for a longer period for statistical purposes with the appropriate safeguards in place (data aggregation).

- Your contact details submitted via the registration form will be kept for six months following the JECPD 2024 or at the latest after the last follow-up action.
- Your dietary restrictions and special health needs will be deleted after the end of the JECPD 2024.
- The personal data processed by the processor for the pre-event production of JECPD 2024 badges will be deleted by the processor once the production is completed.
- Videos and photos of the JECPD 2024 and social events organised by the EBA will be archived after 10 years and will not be available on the EBA websites any more after that period. Please note however that, once videos and photos are uploaded online, it can be used by third parties for their own purposes, in their own platforms, and sometimes without the EBA being informed. In such cases, please note that it may not be possible for us, notwithstanding any implemented safeguards, to ensure removal from the internet after the retention period has expired.

The first and last name, e-mail address and affiliation will be retained for future mailing lists in relation to JECPD events. This mailing list is regularly updated for future JECPD events. Inactive email addresses will be manually removed on an annual basis. Requests for personal data deletion from the distribution list and unsubscription will be processed within one month.

Further information on the processing of personal data in relation to registration for the event and attendance during the event is provided at later stages to the data subjects concerned.



### Why do we process your personal data and under what legal basis?

The lawfulness for the organisation, management and follow up of this event for the EBA is Article 5(1)(a) of EUDPR as the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body and in particular in the context of Article 9 of the EBA Regulation.

You receive this communication based on your consent (Article 5(1)(d) of the Regulation).

This is a joint ESAs event. The distribution list for the communication of the information related to this event is based on the distribution lists of the European Insurance and Occupational Pensions Authority, European Securities and Markets Authority and EBA.

When visiting the EBA website, your personal data will only be processed for aggregated statistics based on your consent. For more information, please refer to the cookies notice.

### Will the processing of your personal data involve any transfer outside of the EU?

Your personal data is processed within the EU/EEA and will not leave that territory.

#### What are your rights regarding your personal data?

As a data subject, an individual whose personal data is processed, you have the following rights:

Access - You have the right of access to your personal data and to relevant information concerning how we use it.

Rectification - You have the right to rectify your personal data, where there are inaccuracies or where data is incomplete.

Erasure - Under certain conditions, you have the right to ask that we delete your personal data.

Objection - You have the right to object to the processing of your personal data on grounds related to your particular situation. If you do so, EBA may only continue processing your personal data where overriding legitimate grounds can be demonstrated or where the processing is necessary for the establishment, exercise or defense of legal claims.



Restriction - Under certain conditions, you have the right to ask that we restrict the use of your personal data or momentarily pause the processing conducted on the data.

Right to Withdraw Consent – Where the EBA relies on consent as the legal basis for processing your personal data you have the right to withdraw your consent at any time.

### You have the right to lodge a complaint

You have, in any case, the right to lodge a complaint with the European Data Protection Supervisor, our supervisory authority for data protection matters.
