

Data Protection Notice – Reporting Contact Group Call for Expression of Interest

Call for Expression of Interest

The European Banking Authority (EBA) processes your personal data in the context of the call for expression of interest for the Reporting Contact Group (RCG). The EBA processes your personal data based on Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC with EEA relevance (EUDPR).

The following information is provided as established in Articles 15 and 16 of the EUDPR.

Who is the controller?

The EBA is the controller with regard to the data processing activities described in this data protection notice.

What personal data do we process, for what purpose, who can access it and how long do we keep them?

Categories of persons whose data is processed (i.e. potential RCG members) in the context of the above-mentioned RCG Call for Expression of Interest: Members from the banking industry operating in the EEA area or other industry offering reporting services to the banking sector - includes individual representatives and representatives of associations currently employed by or acting on behalf of EEA banking institutions, representing the diverse models and sizes of banking institutions and businesses.

The following categories of personal data are processed in the context of the above-mentioned RCG Call for Expression of Interest: full name; ; telephone number; email address; nationality; information on the employer, Curriculum vitae containing any information provided by applicants, such as employment history, academic history, biographical information; photograph; For the selected members will be processed personal data related to conflict of interest declaration; consent to revisit the application and confidentiality agreement.

The call will be launched on the EBA website and information will be disseminated on social platforms as well. Given the role of the European Central Bank (ECB) in the set-up of the Joint Bank Reporting Committee (JBRC), a link to the call will be published on the ECB website as well.

Personal data will be processed for the following purposes:

- Call for expression of interest and selection of members of the RCG. The selection and appointment of members will be done by the JBRC;
- Establishment of a reserve list of candidates for potential appointments - will be done by the JBRC;

Personal data is received via the EBA website EU Survey application ([privacy notice](#)) and stored internally in access-controlled EBA locations.

Your personal data can be accessed and shared with the JBRC members (including European and National authorities). Some personal data of successful applicants will be made public on the EBA and ECB websites (e.g. name, photograph and some biographical details).

The EBA will keep the personal data of applicants processed for the above purposes for up to four years - after three years a new selection of RCG members or three-year renewal takes place. The personal data may be transferred as part of the information referred to in Articles 15 and 16 EUDPR. In the case of legal challenge, personal data will be stored until the matter concerned is resolved.

Why do we process your personal data and under what legal basis?

Your personal data are processed for the abovementioned purposes which are linked to the appointment of RCG members and to supporting the continuous effective composition of the RCG as is necessary for the performance of the JBRC's tasks. This is in line with [Memorandum of Understanding](#) and accompanying Charter on the establishment of the JBRC between the European Central Bank (ECB) and the European Banking Authority (EBA) which provides for the composition and operation of the RCG. As such, the processing of your personal data by the JBRC is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the EBA pursuant to Article 5(1)(a) of the EUDPR. The participation in this call for expression of interest is completely voluntary.

Will the processing of your personal data involve any transfer outside of the EU?

Your personal data is processed by the EBA within the EU/EEA and will not leave that territory.

What are your rights regarding your personal data?

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you. For more information, please see Articles 14 to 21, 23 and 24 EUDPR.

You have the right to lodge a complaint
